Child Protection and Creating Safe Environments – January is Human Trafficking Prevention Month. In 2024, the National Center for Missing & Exploited Children received over 27,800 reports of possible child sex trafficking. The average age of child sex trafficking victims is 15 years old. Child sex trafficking is child abuse. It occurs when a minor is advertised, solicited, or exploited through a commercial sex act-where sex is exchanged for money, food, shelter, drugs, or anything of value. Traffickers can be family members (even parents), friends, gangs, foster parents, trusted adults or boyfriends. Talk openly with your child about this reality and build resiliency. Address myths that glamorize the commercial sex industry. Warn about online risks: social media and gaming platforms are used by traffickers to target, groom, and recruit victims. Prepare your child: at some point they will likely encounter inappropriate messages or harmful content online. Teach them how to respond safely. Report suspected child sex trafficking by calling 1-800-843-5678 or visit CyberTipline.org.

Child Protection and Creating Safe Environments- Al-generated Explicit Images. With the rising use of Al, explicit nonconsensual images can be generated easily and without the victim's knowledge. An offender may not even need an explicit image to work from. When threatened with explicit Al-generated images being published or distributed online, victims often succumb to demands for money, in-persons meetings or worse. This can affect anyone, regardless of age or gender – but children are most at risk. The National Center for Missing and Exploited Children provides a free service called, "Take It Down," that can help one remove or stop the online sharing of nude, partially nude, or sexually explicit images or videos of minors. Child Protection and Creating Safe Environments – Cyberbullying.

The widespread use of mobile devices causes more children to be susceptible to cyberbullying. Cyberbullying can take many forms, including cruel messages via text or social media, the distribution of photoshopped pictures designed to mock an individual, forwarding "private" photos or videos, and pretending to be someone else on a social media site. Victims of cyber bullying often suffer from depression, isolation, and can even become suicidal. Child Abuse Prevention Month: Who is a Mandated Reporter? A mandated reporter is required by Pennsylvania law and the diocesan Policy for the Protection of Children to report

suspected or disclosed cases of child abuse to ChildLine or law enforcement. Mandated reporters in our diocese are people who hold positions of trust in our schools, parishes, agencies, and institutions. All clergy, employees and volunteers working/serving in our parishes, schools or agencies are mandated both legally and morally to report any reasonably suspected or known child abuse to ChildLine, the local law enforcement, or other appropriate agency. Child Abuse Prevention Month- Report Child Abuse: It is every adult's moral responsibility to report known or suspected abuse or neglect of a minor to the responsible authorities. Physical and sexual abuse of minors are pervasive societal problems, and only concerted and sustained efforts by all adults in every segment of society can help to protect children and youth. According to the latest Pennsylvania statewide report in 2024 there were 5,214 substantiated reports of child abuse. 1,693 or 32.5% of the substantiated reports were for sexual abuse and 1,410 substantiated reports were physical abuse. 61.4% of child abuse victims were female. Mother and Father remain the person most responsible for abuse of their children. To report child abuse, call Childline at 800-932-0323 (anytime 24/7). Child Abuse Prevention Month: Be Vigilant: Keeping kids safe starts with all of us. Pay attention to how people interact with children – and speak up if something feels off. Notice the signs of abuse, take them seriously and report concerns right away. If you see behavior that seems inappropriate or just doesn't feel right, don't ignore it. Reporting could prevent harm. Your child's personal info online is easy to track—and hard to erase. Protect them with these simple steps: Never share personal details like full name, address, phone number, email, school, or birthday on social media. Keep passwords private — never give them to anyone. Check privacy settings on games, apps, social media, and devices. Turn off GPS sharing to prevent location leaks. Avoid public WI-FI when sharing personal info.

Child Protection and Creating Safe Environments- Teach Children to Protect Themselves at Home Keeping kids safe starts at home. Talk to your children about simple ways they can protect themselves: Know who's at the door – Never open it for strangers. Keep personal info private – Don't share your name, address, or phone number with anyone you don't know. Emergency contacts – Make sure your child knows how to reach you and call 911 if needed. Safe boundaries – teach them to say "no" to anything that makes them uncomfortable. Online safety – Remind them not to share personal details or passwords online. to protect children. All clergy, employees and volunteers who work with children must complete state mandated criminal record checks. They must also follow screening guidelines and complete abuse prevention training. These steps help ensure that everyone who has access to children in our schools and parishes is properly vetted and trained. Parents: stay vigilant! Make sure anyone who interacts with your child has completed the application process and obtained the required clearances and training. November is designated **National Homeless Youth Awareness Month**, a critical time to raise awareness about the challenges facing young people experiencing homelessness. Annually approximately 1.2 million children under age 6 and 4.3 million youth and young adults experience homelessness. Youth without stable housing face a high risk of trauma, violence, substance abuse, sex trafficking and mental health issues. Homeless high school students were nearly twice as likely to consider suicide and over three times as likely to attempt it compared to housed students.
