Envisioned as an initiative for the Easter season, the Invite One Back resources are designed to help parish leaders reach out to parishioners who have not returned to Mass since the pandemic.

## 2024 Calendar Notes

- The Solemnity of the Annunciation of the Lord on March 25 is impeded by Monday of Holy Week. According to the Universal Norms on the Liturgical Year and the Calendar, no. 60, the Annunciation is therefore transferred to Monday of the Second Week of Easter, in this case, April 8, 2024.
- Since December 8, 2024 is the Second Sunday of Advent, the **Solemnity of the Immaculate Conception of the Blessed Virgin Mary** is transferred to Monday, December 9; the obligation to attend Mass, however, does not transfer. While Funeral Masses are not normally permitted on this day, they may take place this year since Immaculate Conception is not a day of precept (General Instruction of the Roman Missal, no. 380). The Optional Memorial of Saint Juan Diego Cuauhtlatoatzin, December 9, is omitted.

There are two remaining occasions when non-obligatory Solemnities either precede or follow a Sunday: **the Nativity of Saint John the Baptist** (Monday, June 24), and **Saints Peter and Paul** (Saturday, June 29).

- On **Sunday evening, June 23,** the Mass of the 12th Sunday in Ordinary Time is celebrated, though at a Mass outside the usual schedule, the Vigil Mass of the Nativity of Saint John the Baptist may take place. At the Liturgy of the Hours, Evening Prayer I of the Nativity of Saint John is used; nevertheless, Evening Prayer II of the 12th Sunday may take place in celebrations with the people.
- On **Saturday evening, June 29**, at normally scheduled anticipated Masses, priests should anticipate the Mass of the 13th Sunday of Ordinary Time, though at Masses outside that usual schedule, the Mass of Saints Peter and Paul may be used. At the Liturgy of the Hours, Evening Prayer II of Saints Peter and Paul is used.

The Commemoration of All the Faithful Departed (All Souls' Day) falls on a Saturday this year. On Friday evening, All Saints Day is celebrated at the Mass and the Liturgy of the Hours, though, for pastoral reasons where it is the custom, Evening Prayer II of All Saints may be followed by Evening Prayer for the Dead. On Saturday evening, priests should anticipate the Mass of the 31st Sunday of Ordinary Time at normally scheduled anticipated Masses, though the Mass of All Souls' Day may be used outside that usual schedule. At the Liturgy of the Hours, Evening Prayer I of the 31st Sunday of Ordinary Time is used in individual recitation, though Evening Prayer for the Dead may be used in celebrations with the people.

# Masses for the Neophytes and a Pentecost Celebration During Easter Time

The *Rite of Christian Initiation of Adults* provides helpful guidance for the pastoral care of the newly baptized adults at Easter:

# 247 Since the distinctive spirit and power of the period of postbaptismal catechesis or mystagogy derive from the new, personal experience of the sacraments and of the community, its main setting is the so-called Masses for neophytes, that is, the Sunday Masses of the Easter season. Besides being occasions for the newly baptized to gather with the community and share in the mysteries, these celebrations include particularly suitable readings from the Lectionary, especially the readings for Year A. Even when Christian initiation has been celebrated outside the usual times, the texts for these Sunday Masses of the Easter season may be used.

# 248 All the neophytes and their godparents should make an effort to take part in the Masses for the neophytes and the entire local community should be invited to participate with them. Special places in the congregation are to be reserved for the neophytes and their godparents.

The homily and, as circumstances suggest, the general intercessions should take into account the presence and needs of the neophytes.

# 249 To close the period of postbaptismal catechesis, some sort of celebration should be held at the end of the Easter season near Pentecost Sunday; festivities in keeping with local custom may accompany the occasion.

### Masses for Various Needs and Occasions: For Peace

As we celebrate new life in Christ in this Easter Season, do not forget those who suffer the ravages of war. Bishop Persico encourages the continued use of the Masses for Various Needs and Occasions #30 For the Preservation of Peace and Justice, #31 In Time of War or Civil Disturbance, and #32 For Refugees and Exiles during the season of Easter. While the priest has much latitude using these Mass texts during the Easter Season, it is asked that they not be used more than once a week and not on the days prohibited as follows:

- The Sundays of Easter
- The Days of the Easter Octave
- The Solemnity of the Annunciation, April 8
- The Solemnity of the Ascension of the Lord, May 9
- The Feast of Saint Mark, April 25
- The Feast of Saints Philip and James, May 3
- The Feast of Saint Matthias, May 14
- The Feast of the Dedication of Saint Peter Cathedral, May 17

# **Proper Disposal of the Paschal Candle**

Old paschal candles, as blessed objects (a sacramental) must be appropriately disposed. This could involve burning the candle in a devotional manner (privately as opposed to publicly and liturgically) or even burying the candle in blessed ground. Candles are made to be burned, however, and it is better to find a way to either recycle or burn the wax.

# Time for Vigil and Anticipated Masses

The time for Vigil Masses and Anticipated Masses in the Diocese of Erie is no earlier than 4:00 pm. This applies to Holy Days of Obligation as well, including Christmas.
